



According to the decision of its Management board, Jadrolinija, maritime liner company for the carriage of passengers and goods, Rijeka, Riva 16, OIB: 38453148181, announces the following

INVITATION FOR PUBLIC TENDERS

1. The object of the tender is Ro-Ro passenger vessel "**DUBROVNIK**", IMO No. 7615048, built 1979. in Ireland, flag: Croatia, dually classed: CRS / BV, navigation area: 2 – great coastal service, length o.a. 122,06 m, beam 18,5 m., passenger capacity: 1300, car capacity: 280.
2. Statutory and certificates of classification are valid until 28.03.2023.
3. The initial - lowest selling purchase price shall be **2.850.000,00 EUR**, corresponding to **21.473.325,00 HRK** (conversion rate 1 EUR = 7,53450 HRK).
The offered price of the selected Bidder, which may not be lower than the initial - lowest selling price of the vessel, does not include the price of fuel remaining in the tanks of the vessel.
4. Bidding conditions:
 - Offers (bids) with full company name/ name and surname of the Bidder, the Bidder's address, tax number, proof of payment of the deposit, the number of bank accounts in case of return of the deposit and the offered price in EUR shall be submitted in a sealed envelope to the following address: Jadrolinija, 51 000 Rijeka, Riva 16, with the indication "**Offers for purchase – vessel “Dubrovnik” - DO NOT OPEN.**
 - The sale shall be made according to the principle “**where is/as is**”, whereby any buyer's claims in respect of possible defects shall be excluded.
 - Selection criteria will be the highest offered price.
 - The deadline for submission the offers is October 24th 2022, until 12:00. Bids are submitted to Jadrolinija's Mail office at the address Jadrolinija, Rijeka, Riva 16, Croatia.
 - The public opening of the tenders shall be held on October 24th 2022 at 12:00 in the premises of Jadrolinija, Rijeka, Riva 16, third (III) floor.
 - Any legal or natural entity can participate in the process of tendering if they submit, with the bid, a proof that they have paid on Jadrolinija's bank account number:

- The winning bidder's deposit shall be included in the purchase price and other bidders' deposits shall be duly returned within eight (8) days after the conclusion of the tender procedure.

- Within the deadline for submission of offers, the Bidder may amend or withdraw its offer with an additional, valid signed statement. The said statement of modification or withdrawal of the offer must be submitted to Jadrolinija before the deadline for submission of bids specified in these bidding conditions.
- Bidders shall be notified in writing of the results of the tendering procedure.
- The winning bidder shall be required to enter into Memorandum of Agreement with Jadrolinija within seven (7) days from the receipt of MoA draft. The deposit shall not be returned to the winning bidder in case of their failure to enter the MoA within the term prescribed in the previous clause.
- Delivery of the vessel shall be made after the payment of the purchase price on which VAT is calculated and payment proof delivered to Jadrolinija, Rijeka.
- Jadrolinija reserves the right to cancel the tender or reject all bids before their acceptance, of which it will notify all Bidders without stating the reasons for cancellation or rejection. Jadrolinija does not sustain any responsibility in case of cancellation of the tender procedure, rejection of the Bidder and does not take any costs related to the participation of the Bidder in the tender.
